Dear Secretary Becerra:

The Select Subcommittee on the Coronavirus Pandemic, the Committee on Oversight and Accountability, and the Committee on Energy and Commerce ("the Committees") are jointly investigating the origins of the COVID-19 pandemic. At the beginning of this Congress, the Committees sent requests for responsive documents and communications from the Department of Health and Human Services ("HHS" or the "Department"), specifically but not limited to documents in the custody of the National Institutes of Health (NIH) and the National Institute of Allergy and Infectious Diseases (NIAID).

We have a Constitutional duty to conduct thorough oversight and evaluate legislative solutions to address deficiencies and engrain proficiencies within the federal government. The Committees will use this investigation to inform potential legislation to improve pandemic preparedness, strengthen grant processes and oversight, and enhance biosafety and biosecurity of laboratory and field research. This may also include amending or strengthening current criminal laws regarding defrauding the United States.

This letter consolidates our previous requests regarding the origins of COVID-19 and, as a further accommodation to the Department, tables some requests, adds significant topic specificity, scopes down the time frame of our previous requests, and prioritizes requests most important to the Committees. Considering these significant accommodations, we expect full and timely compliance with each request.

If the Department fails to meet any of the prescribed deadlines, the Committees will be forced to consider the use of the compulsory process.

If a witness is unable to participate on the requested dates, please inform the Committees at least one week prior. If any of these dates are missed by the Department for invalid reasons, the Committees will consider the use of the compulsory process.

Additionally, for each of the above letters, provide the Committees with how many new or unique searches or pulls of information conducted by the Department and on what dates, a list of search terms used for these pulls, and a list of custodial inboxes searched as soon as possible but no later than **September 21, 2023**. Within the terms of the February 13, 2023 letter, if the Department fails to meet this deadline and considering the pace of production and recent concerns regarding excessive redactions, we reiterate our previous request that the following individual testify at a voluntary transcribed interview on the following date:

1. Ms. Melanie Egorin: September 28, 2023

If this date is missed by the Department for invalid reasons, the Select Subcommittee will be forced to consider the use of the compulsory process. However, if the Department meets the September 24 deadline, Ms. Egorin's transcribed interview request will be withdrawn.

The Select Subcommittee on the Coronavirus Pandemic is authorized to investigate "the origins of the Coronavirus pandemic, including but not limited to the Federal Government's funding of gain-of function research" and "executive branch policies, deliberations, decisions, activities, and internal and external communications related to the coronavirus pandemic" under H. Res. 5. The Committee on Oversight and Accountability is authorized to investigate "any matter" at "any time" pursuant to House Rule X. The Committee on Energy and Commerce is the authorizing committee with jurisdiction and oversight responsibilities for public health service agencies, including the NIH and the entities it funds, as well as federal biomedical research and development.

Further, House Rule XI clause 2(m)(1)(B) grants Committees of the House of Representatives with the authority "to require, by subpoena or otherwise, the attendance and testimony of such witnesses and the production of such books, records, correspondence, memoranda, papers, and documents as it considers necessary."
