Dear Secretary Raimondo:

We write to request information on the recent decision by U.S. Department of Commerce (Commerce) to cease issuing new export licenses related to certain firearms, firearm components, and ammunition for approximately 90 days. This action has raised concern about a possible extralegal attempt by the Biden Administration to harm the domestic firearms manufacturing industry in pursuit of an anti-firearm agenda by starving it of access to international markets for at least 90 days, perhaps indefinitely. The Department's mission is to "drive U.S. economic competitiveness, strengthen domestic industry, and spur the growth of quality jobs in all communities across the country." Your Department's recent decision appears to be at direct odds with its mission in service to the political whims of a radical anti-firearm administration. We seek and expect your Department's cooperation in providing additional information to determine a full accounting of this action and how it will impact U.S. firearms manufacturers and the jobs that industry provides.

On October 27, 2023, the Bureau of Industry and Security (BIS) announced that it would, "[e]ffective immediately... pause[] for approximately 90 days the issuance of new export licenses involving certain firearms, related components, and ammunition under its jurisdiction..." with exceptions for a limited list of countries.<sup>3</sup> In addition to pausing export licenses, the International Trade Administration (ITA), which assists entities and individuals seeking to have access to U.S. manufactured goods, will also "pause[] acceptance of new requests for export assistance (fee or non-fee-based) for firearms and ammunition to non-

governmental end users worldwide..." except for those located in certain listed countries.<sup>4</sup> Specifically, the announced "pause" applies to issuances of new licenses for any item related to four Export Control Classification Numbers (ECCNs) for to certain firearms, components, and ammunition destined for any non-governmental end user apart from those located in Ukraine, Israel, or those specified in regulations.<sup>5</sup>

This 90 day "pause" is purportedly to enable Commerce "to more effectively assess and mitigate risk of firearms being diverted to entities or activities that promote regional instability, violate human rights, or fuel criminal activities." Commerce, however, did not provide any examples of such activity or any explanation why existing export regulations need amending to address the alleged issues. Commerce's "pause" also only includes the ECCNs pertaining to firearms, but does not include those pertaining to items such as "specially designed' implements of torture, including thumbscrews, thumbcuffs, fingercuffs, spiked batons." This inconsistency of application calls into question whether Commerce's alleged human rights rationale is a pretext to target the domestic firearms manufacturing industry.

To enable oversight into the possible politicization of Commerce's activities intended to further build out American industry's access to global markets and targeting of the firearm industry by this administration, provide the following documents and communications as soon as possible, but no later than December 12, 2023:

- 1. All documents and communications related to the 90-day Firearms Export Control Pause & Review referenced above within Commerce or between any individual within Commerce and any other federal agency;
- 2. All documents and communications related to the 90-day Firearms Export Control Pause & Review referenced above between Commerce and the White House or any official within the Executive Office of the President:
- 3. All documents and communications containing any guidance to BIS or ITA officials on effectuating their roles and responsibilities related to any matter pertaining to goods described by ECCNs 0A501, 0A502, 0A504, and 0A505 during the pause; and
- 4. All documents and communications related to the announced assessment of current firearm export control review policies.

Additionally, please provide a staff-level briefing on this matter as soon as possible, but no later than December 5, 2023. Briefers should be prepared to provide a full explanation of the rationale for instituting the 90-day pause within Commerce, an explanation of whether the idea to institute the pause originated outside of Commerce and what other entities within or without the federal government were involved in the decision, specific information regarding the announced assessment of current firearm export control review policies to include the individuals involved in the assessment and the timeline for completion, and Commerce's assessment of the impact to the domestic firearms industry.
